RESOLUTION TO REDUCE THE REVISED 2025 CD&D BUDGET**

Mr. Knapp moved for adoption of the following resolution

WHEREAS, the Health Commissioner is recommending a budget revision to reduce the revised 2025 CD&D budget as previously approved by the Board of Health on February 10, 2025, which allowed the agency to create additional purchase orders under the CD&D budget to allow for lead hazard reduction efforts. In February, there was concern that the Housing & Urban Development (HUD) grant funds covering lead hazard reduction may be cut after we contracted with vendors on these efforts. The HUD grant funds remained in total and we did not have to use any of the funds approved in Resolution A.

NOW THEREFORE BE IT RESOLVED that the Board of Health of the Hamilton County General Health District hereby approves the revised 2025 budget by decrease in expenditures to OCA 930199 (CD&D)/Sub Fund 013, OBJ3 910, by the amount of \$400,000.00.
