PLEASE CALL THE WASTE MANAGEMENT DIVISION AT (513)946-7879 TO CHECK AVAILABILITY, RESERVE A VACUUM AND/OR SCHEDULE AN APPOINTMENT FOR

PICK-UP OR DROP-OFF.

- <u>LOCATION</u> ALL PICK-UPS WILL BE AT THE HAMILTON COUNTY PUBLIC HEALTH OFFICE LOCATION AT 250 WILLIAM HOWARD TAFT ROAD, 2ND FLOOR, CINCINNATI, OHIO, 45219.
- **<u>RENTER'S AGREEMENT</u>** A RENTER'S AGREEMENT MUST BE SIGNED WHEN PICKING UP THE VACUUM CLEANER. YOU MUST PRESENT A VALID OHIO DRIVER'S LICENSE FOR VERIFICATION AT TIME OF PICK-UP AS WELL AS A \$100 DEPOSIT (SEE BELOW).
- <u>DEPOSIT</u> A DEPOSIT OF \$100 IN THE FORM OF CASH, CHECK OR MONEY ORDER ONLY WILL BE REQUIRED AT TIME OF PICK-UP. THIS WILL BE REFUNDED AT TIME OF DROP-OFF PROVIDED ALL PIECES ARE RETURNED AND THE VACUUM IS RETURNED <u>CLEANED</u>. DEPOSIT WILL BE KEPT IN THE WASTE MANAGEMENT DIVISION OFFICE.
- <u>**INVENTORY</u>** A COMPLETE LIST OF PARTS AND THE VACUUM'S SERIAL NUMBER WILL BE KEPT AS PART OF YOUR AGREEMENT. ALL OF THE INVENTORIED ITEMS MUST BE RETURNED AT THE TIME OF DROP-OFF.</u>
- <u>CONDITION</u> THE VACUUM AND ITS ASSOCIATED PARTS MUST BE RETURNED IN CLEAN CONDITION IN ORDER TO AVOID FORFEITING PART OR ALL OF YOUR DEPOSIT.

- <u>COLLECTION BAG</u> THE RENTER IS RESPONSIBLE FOR DISPOSING OF THE COLLECTION BAG PRIOR TO DROP-OFF AT THE 250 WILLIAM HOWARD TAFT ROAD, 2ND FLOOR, OFFICE LOCATION. COLLECTION BAGS MAY BE SET OUT WITH REGULAR TRASH.
- **<u>RENTAL PERIOD</u>** VACUUMS MAY BE RENTED FROM UP TO ONE WEEK. LONGER RENTAL PERIODS ARE POSSIBLE UNDER CERTAIN CIRCUMSTANCES.
